The authors describe how such hashtags as #MeToo, #SurvivorPrivilege, and #WhyIStayed have challenged the conventional understanding of

gendered violence; examine the voices and narratives of Black feminism enabled by #FastTailedGirls, #YouOKSis, and #SayHerName; and explore the creation and use of #GirlsLikeUs, a network of transgender women. They investigate the digital signatures of the “new civil rights movement”—the online activism, storytelling, and strategy-building that set the stage for #BlackLivesMatter—and recount the spread of racial justice hashtags after the killing of Michael Brown in Ferguson, Missouri, and other high-profile incidents of killings by police. Finally, they consider hashtag created by allies, including #AllMenCan and #CrimingWhileWhite.

Starting in Northern Europe, these policies have expanded to other European countries and later to thirteen Latin American countries. Yet, whereas gender quotas in most European countries - with the exception of Belgium and France - have been adopted voluntarily by some political parties, in Latin America national legislation mandates all parties to include in their lists a quota for women candidates to legislatures. Although recent scholarship on gender quotas has been devoted to the adoption of gender quotas in a variety of countries, little has been done on Central and South America, despite the fact that the legislative «quota wave» originated there.
