On the other hand, those located on the U.S. side, were subjected to mischief and flagrant violations of the terms of the Treaty of Guadalupe Hidalgo. Sadly, in 1953, the Falcon Dam inundated Guerrero Viejo and many of the land grants. Thus, for all intents and purposes, the heirs of most land grants met the same end and a financial obligation (of \$193.0 Million plus interest) exchanged between the U.S. and Mexico has remained unpaid for over 80 years. Capt. Marcos Alonso Garza was from Lepe in Huelva province in Andalucía, Spain, and immigrated to Mexico City, where he married Juana de Treviño. He moved to Guadiana (now the city of Durango), Durango, and later possibly married Catalina Martínez Guajardo. He then moved to Monterrey, Nuevo León, and died before 1643. Some of his sons used surnames of "Garza," "de la Garza," and "de Treviño" (it was quite common for later sons to use a mother's surname). Descendants and relatives lived in Durango, Nuevo León, Tamaulipas, Coahuila and elsewhere.

The historical record of the Rio Grande valley through much of the nineteenth century reveals well-documented violence fueled by racial hatred, national rivalries, lack of governmental authority, competition for resources, and an international border that offered refuge to lawless men.
