The British Christian Women's Movement Crossway
This title was first published in 2002. This book presents a timely study of a neglected British Christian women's movement. Jenny Dagers charts the inception of the movement in the exciting times of the post-sixties decades, amid new currents generated in the British denominational churches, and the wider current of Women's Liberation. Focusing on Christian women's concern with the position of women in the church, this book identifies a core Christian women's theology which affirms a (rehabilitated) 'new Eve in Christ', and so contrasts with a concurrent paradigm shift taking shape in North American feminist theology. Dagers argues that this divergence is primarily due to the effect of the prolonged Church of England women's ordination debate upon the ethos of the British Christian women's movement.

Men and Women in the Church Univ. Press of Mississippi Unlike many cities farther north, Kansas City, Missouri-along with its sister city in Kansas-had a significant African American population by the midnineteenth century and also served as a way station for those migrating north or west. "Take Up the Black Man's Burden" focuses on the people and institutions that shaped the city's black communities from the end of the Civil War until the outbreak of World War II, blending rich historical research with first-person accounts that allow participants in this historical drama to tell their own stories of struggle and accomplishment. Charles E. Coulter opens up the world of the African American community in its formative years, making creative use of such sources as census data, black newspapers, and Urban League

records. His account covers social interaction, employment, cultural institutions, housing, and everyday lives within the context of Kansas City's overall development, placing a special emphasis on the years 1919 to 1939 to probe the harsh reality of the Depression for Kansas City blacks-a time when many of the community's major players also rose to prominence. "Take Up the Black Man's Burden" is a rich testament not only of high-profile individuals such as publisher Chester A. Franklin, activists Ida M. Becks and Josephine Silone Yates, and state legislator L. Amasa Knox but also of ordinary laborers in the stockyards, domestics in white homes, and railroad porters. It tells how various elements of the population worked together to build schools, churches, social clubs, hospitals, the Paseo YMCA/YWCA, and other institutions that made African American life richer. It also documents the place of jazz and baseball, for which the community was so well known, as well as movie houses, amusement parks, and other forms of leisure. While recognizing that segregation and discrimination shaped their reality, Coulter moves beyond race relations to emphasize the enabling aspects of African Americans' lives and show how people defined and created their world. As the first extensive treatment of black history in Kansas City, "Take Up the Black Man's Burden" is an exceptional account of minority achievement in America's crossroads. By showing how African Americans saw themselves in their own world, it gives readers a genuine feel for the richness of black life during the interwar years of the twentieth century.

Jerrilyn McGregory explores sacred music and spiritual activism in a little-known region of the South, the Wiregrass Country of Georgia, Alabama, and North Florida. She examines African American sacred music outside of Sunday church-related activities, showing that singing conventions and anniversary programs fortify spiritual as well as social needs. In this region African Americans maintain a social world of their own creation. Their cultural performances embrace some of the most pervasive forms of African American sacred music--spirituals, common meter, Sacred Harp, shape-note, traditional, and contemporary gospel. Moreover, the contexts in which they sing include present-day observations such as the Twentieth of May (Emancipation Day), Burial League Turnouts, and Fifth Sunday. Rather than tracing the evolution of African American sacred music, this ethnographic study focuses on contemporary cultural performances, almost all by women, which embrace all forms. These women promote a female-centered theology to ensure the survival of their communities and personal networks. They function in leadership roles that withstand the test of time. Their spiritual activism presents itself as a way of life. In Wiregrass Country, "You don't have to sing like an angel" is a frequently expressed sentiment. To these women, "good" music is God's music regardless of the manner delivered. Therefore, Downhome Gospel presents gospel music as being more than a transcendent sound. It is local spiritual activism that is writ large. Gospel means joy, hope, expectation, and the good news that makes the soul glad.

The Dexter Avenue King Memorial Church played an important role in the Civil Rights movement-it was the backbone of the

Montgomery bus boycott, which served as a model for other grassroots demonstrations and which also propelled Martin Luther King, Jr. into the national spotlight. Building on Wings of Faith In 1868, with the nation in general disarray following the American Civil War, the Methodist Church began to form mission churches for freed Blacks in the South. It was out of these mission efforts that the historically important Stewart Memorial Methodist Church was founded in 1893 Daytona, Florida. In 1939, when several Methodist Churches reunited and assumed the title Methodist Church, Black Methodist Churches were included, but they were placed in the segregated Central Jurisdiction of the Methodist Church. Stewart Memorial Episcopal Church was renamed Stewart Memorial Methodist Church. There was still another change to come. When several Methodist-based churches united in 1967 and became the United Methodist Church, Stewart Memorial assumed its present name, Stewart Memorial United Methodist Church. Since its beginning, more than forty ministers have served pastoral charges at Stewart Memorial. Through the years, the United Methodist Church evolved, and so did Stewart Memorial, but the basis foundation of Methodism was unshakable. Methodism, as perceived by John Wesley, emphasized small group worship, which was described as: "A company of men having the form and seeking the power of godliness, united in order to pray together, to receive the word of exhortation, and to watch over one another in love, that they may help each other to work out their salvation." Making up these small groups under Wesley were those who had "a desire to flee from the wrath to come, and to be saved from their sins." It is upon the sound foundation of

Methodism, as emphasized by Wesley, that Stewart Memorial was founded and continues to exist.
