Writing and Victorianism asks the fundamental question 'what is Victorianism?' and offers a number of answers taken from methods and approaches which have been developed over the last ten years. History, ancestry, and the past all play their part in figuring the present in the nineteenth-century, and many of these studies foreground the problem of literary, social, and psychological identity.

Though he wrote more than a century ago, French author Victor Hugo (1802-1885) continues to capture the imagination of contemporary readers both in France and around the world. In the United States, he is best remembered as the author of the novel Les Mis^D'erables (1862), which has been adapted for the stage, and of Notre-Dame-de-Paris (1831), more commonly known to Americans as The Hunchback of Notre Dame. But Hugo was also a poet and dramatist, a great religious and social thinker, and one of the most important shapers of French Romanticism. As a poet, he created new verse forms, explored historical and mythological themes, and criticized social issues of his time. Through his drama, he united prose and poetry and examined the politics of England and Spain. In all of his works, he discussed such theological and social issues as the problem of evil, the nature of war and peace, and the problems of capital punishment. The volume begins with a short biography that places Hugo within the context of 19th-century France. The biography tells of his early years during which he began to form his religious and political views, his maturation as a writer and thinker during the 1830s, and his political exile, during which he wrote some of his finest poetry. The alphabetically arranged entries that follow discuss his works, characters, themes, and ideas, as well as historical persons and places that figured prominently in his life and writings. Many of the entries cite sources of additional information, and the volume closes with a selected, general bibliography.

Once more good people shelter him, rescuing him without assistance ofthe Bow Street officers, who make brave talk. The kind old scholar, Mr. Brownlow, is the good genius who opens before him a way to liberty and a life suited to his nature. The excitable country doctor deceives the police, and saves Oliver for an honest career. The eccentric Mr. Grimwig should not be overlooked. The mystery of his mother's fate is solved, and he finds a sister ...

While quite a bit of work has been done about cook books, recipes and their development through time along the lines of text linguistics, in the past years the very interesting and intriguing field of how we perceive and describe taste has increasingly been taken up by cognitive linguists (Magee 2009). Cooking shows on

television, however, have not been taken into consideration. Such programmes have already been popular in radio broadcasting, made it to television in its very beginning in the 1940s, found enthusiastic fans in every generation at least since Julia Child's *The French Chef* on WGBH in 1962 and have increased in popularity ever since (Collins 2009). In 1999, a soon to be very important and internationally acclaimed hero of the genre found his way onto the screen in the BBC cooking show *The Naked Chef*, clearly taking its cue from Child's show: Jamie Oliver. The style of *The Naked Chef* was new, young and cool, and later found copies such as the German show *Schmeckt nicht, gibt's nicht* (2004) with Tim Mälzer. Oliver is supposed to have brought good taste as well as ease into British kitchens by showing people what was really wanted, namely easy and fast but healthy cooking in a relaxed atmosphere similar to the one put across by the show. As Trevor Clawson states: [...] fans and detractors alike know that 'our Jamie' speaks in the unschooled voice of ordinary British people. If you want to hear words such as 'pukka', 'malarkey' and 'luvvly jubbly' spoken over the preparation of 'Rosemary Skewered Monkfish', then Oliver is your man." (Clawson 2010). This
