*Intergovernmental Fiscal Relations* Juta and Company Ltd

The main objective of this book is to restate the important theories and evidence from economic analysis concerning intergovernmental fiscal issues. More importantly, the second objective of the book is to identify gaps in knowledge, empirical uncertainties, and missing theoretical structures and then to establish a preliminary agenda for new research on this topic. The book is organized in two sections. The first covers the core body of intergovernmental fiscal relations, including optimal size for jurisdictions and assignment of public sector functions, the formulation and execution of tax policy in an intergovernmental setting, and the appropriate structure and use of intergovernmental transfers. In the second section, the core knowledge is applied to four major policy areas: education, welfare, fiscal interaction in urban areas, and economic development. In thinking about a new research agenda, the authors call for more current and authoritative estimates of fiscal incidence, including interjurisdictional spillovers, for more fundamental research about the federation process and effects of consolidation, for new evidence about the long run, general equilibrium effects of interjurisdictional competition, and for basic research about the choice process and establishment of intergovernmental fiscal institutions and policies by federal and subnational governments.

This book foregrounds emerging and different perspectives on the centenary of the ANC which was celebrated in February 2012. Differing in tenor, methodology and style, we present nineteen chapters that tackle various epochs and events in the making of the centenary of the oldest political organisation in Africa. The book offers new angles to our understanding of what sustained the ANC over one hundred years in spite of all the internal and external contradictions. There is arguably a view that part of what distinguishes the ANC from other revolutionary movements in the continent is that from the turn of the twentieth century its founders prioritised national unity across tribal, ethnic, linguistic, religious, gender and racial identities. This ideal of national unity informed their responses to the formation of the Union of South Africa in 1910 and the declaration of the South African Republic in 1961. In principle, the leadership was opposed not to these manifestations of concrete nation state formation but to the practice of excluding the majority of South African citizens according to racial markers. As a contribution to the historiography of the ANC and that of South Africa which it was established to liberate, the book tackles the following critical questions: what traits in the ANC's genetic code have kept it alive for one hundred years? Is the ANC on course to meeting its historical mission of building an equitable, nonracial, non-sexist and socially-democratic society as articulated in the Africans' Claims, the Freedom Charter and the Strategy and Tactics documents? Finally, would the ANC continue to retain relevance for a bicentenary especially as it now contends with new internal and external contradictions in an increasingly unequally society and unipolar world order? This new hypothetical architecture, hopefully, will be employed by many others engaged in the study of the rise and fall of political organisations.

Purpose: To share the quality academic papers presented at the International Conference on Business and Management Dynamics (ICBMD) held from 7 to 8 September 2016 at African Pride Crystal Hotel and Spa in Cape Town. As grey literature, the proceedings are the contributions made by researchers at the conference and are considered the written record of the work that was presented to fellow conference delegates. Methodology: The methodology used varies from researcher to researcher but are suitable for the studies conducted. Thus, on the one hand, studies that were subjective in nature used the interpretive paradigm, where the qualitative approach adopted made use of the interview method to collect data. On the other hand, studies that were objectively inclined adopted the positivist philosophy and used survey questionnaires to collect data. However, there were some academic papers which used mixed methodology because of the nature of the study. Whatever methodology used adhered to the ethos of the philosophies underpinning the methodology. Contribution made to scholarship: The articles come from individual researchers and each article in the proceedings is unique. Mostly, there is no general argument leading from one contribution to the next. However, it is interesting to note that in the area of economic performance it was evident that real exchange rate and net foreign direct investment contribute more towards innovations in economic growth. With regard to human capital development, papers presented evidence that there exists a definite need to explore the phenomenon of personal branding as limited scientific academic research has been done within the field of personal branding or on elements of the topic. Thus, the outcome argues that personal branding has an influence on leadership style which in turn impacts on organisational performance and related hygiene factors. Furthermore, it was demonstrated that current methods or strategies for enforcing institutionalisation of knowledge sharing within an organisation have not been successful, and, as such, new strategies are needed to reinforce efforts to nurture and invigorate the institutionalisation of knowledge sharing within an organisation. These goals are enshrined in South Africa's Vision 2030 in the National Development Plan.
